POLICIES AND PROCEDURES RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT

In consideration for my pet being permitted to be a client at Michele's Pet Grooming and Boarding, LLC for the day or overnight, I hereby enter into this Policies and Procedures, Release, Waiver of Liability, Assumption of Risk, and Indemnification Agreement and make the following representatives and agree to all of the following policies, procedure, terms and conditions.

1. I represent and certify that all the information contained herein and in the pet application are true and accurate.
2. I represent and warrant that I am the sole owner of the pet.
3. I represent and warrant that my pet meets the following requirements and that he/she has: (a) successfully completed the behavioral interview; (b) is four months of age or older; (c) is spayed or neutered (if over 6 months of age); (d) is current on his/her Rabies, Distemper and Bordatella vaccinations; (e) has not been exposed to Rabies, Distemper, or been ill within a thirty day period prior to attending Michele's Pet Grooming and Boarding,LLC; (f) is in good general health and free of fleas and ticks.; (g) is not aggressive or protective of toys; and (h) tag bearing the pet's name and owner's current contact information. My pet will enter and exit the facility with a leash.
4. I have disclosed and shall continue to disclose on an ongoing basis, any and all medical or other conditions, including but limited to personality concerns or behaviors that may effect, limit, or prevent my pet's ability to participate in play time or attend this facility.
5. My pet may be separated from other pets at the discretion of Michele's Pet Grooming and Boarding, LLC.
6. I agree to pay for all camp fees, services and products, by cash or check (**NO CC ACCEPTED**) at the time I pick up my pet after each visit. I agree to pay the rate for Daycare or Boarding in effect on the date my pet is checked in. I agree to pay all costs and charges or special services requested or needed for the pet and all veterinary costs for my pet during the time my pet is in the care of Michele's Pet Grooming and Boarding, LLC and agree that my pet shall not leave the premises until all charges are paid in full. 7. I understand that I will provide all food for my pet and it will be brought in a sealed/air tight container marked with the pet's name and feeding instructions. If food is not brought your pet will be provided a quality food and an additional charge will be added.

8. I agree that Michele's Pet Grooming and Boarding, LLC shall not be responsible or liable for the loss or damages to personal property either belonging to me or my pet. I also understand that my pet's collar may be removed in the play area to prevent injury to any dog. If my pet causes any damage to the boarding facility or equipment, I agree to be fully responsible and to pay for the full cost of any repair or replacement.
9. I understand and agree that: (a) I will be charged for a full day of day care if I fail to cancel my reservation 24 hours in advance; (b) I will be charged for a full day of boarding if I fail to cancel my boarding reservation at least 48 hours in advance and; © if my reservation is within 3 days of a nationally recognized holiday, I will be charged for a full day of day care or boarding if I fail to cancel my reservation at least 72 hours in advance.
10. I hereby certify that my pet has not harmed or shown aggressive or threatening behavior toward any person or other dog. I understand that aggressive dogs are not permitted to attend Michele's Pet Grooming and Boarding, LLC and that if my pet acts aggressively or exhibits unacceptable behavior, he/she may be separated from the other pets. Reasonable efforts will be made to consult me about aggression and ways to address it, however, aggressive dogs may be asked to leave and not return.
11. I agree that I will not neglect to pick up my pet by a certain time he/she is scheduled to leave without providing prior notice. For every minute I'm late I will be charged \$1.00 extra after 10 minutes I will be charged \$2.00 extra for every minuter thereafter. I agree that any pet that is left at Michele's Pet Grooming and Boarding, LLC without any contact, instruction or notification from me of the ability, willingness or plans to pick him/her up myself or by my personal representative will be considered abandoned upon the 5th day of such notification failure. I understand that if I abandon my pet the facility will, by default, become the legal owner and guardian of the pet and shall, in its sole custody, determine whether to place the pet for adoption or relinquish the pet to unrelated shelter of its choice. **I FULLY UNDERSTAND AND AGREE IF I ABANDON MY GUEST AT MICHELE'S PET GROOMING AND AND BOARDING LLC, I MAY BE UNABLE TO RETRIEVE POSSESSION OF MY PET AND WILL HAVE NO RECOURSE AGAINST MICHELE'S PET GROOMING AND BOARDING,LIC AS PROVIDED HEREIN.**
12. If my pet becomes ill or if the state of my pet's health otherwise requires professional medical attention, Michele's Pet Grooming and Boarding, LLC may, in its sole discretion, engage the services of a veterinarian, administer medicine or give requisite attention to my pet and any and all expenses related to thereto shall by my responsibility.

I HEREBY EXPRESSLY AND FOREVER WAIVE, DISCHARGE AND ALL CLAIMS, RELEASE FROM LIABILITY,SAVE,HOLD HARMLESS AND COVENANT NOT TO SUE MICHELE'S PET GROOMING AND BOARDING, LLC or its invitees, officers, employees, volunteers, agents and representatives from any and all injury ,liability, claim, litigation, action, suit, costs, losses, damages, expenses, or demands (including attorney's fees) of every kind whatsoever arising out of, resulting from or relating in any way to ; a)any act of omission of any Release's, including but not limited to negligence; and b)my or my pet's attendance at Michele's Pet Grooming and Boarding, LLC or in activities. I FURTHER AGREE TO INDEMNIFY, DEFEND, SAVE AND HOLD HARMLESS the Release's from any claims, litigation, actions, suits, damages, costs, attorney's fees, losses or injuries as a result of any such claims. I AGREE THAT THIS RELEASE AND AGREEMENT TO INDEMNIFY SHALL BE BINDING ON ME AND MY SUCCESSORS HEIRS, LEGAL REPRESENTATIVES AND ASSIGNS. I ALSO EXPRESSLY AND FOREVER RELEASE MICHELE'S PET GROOMING AND BOARDING, LLC FROM ANY DUTY TO PROTECT ME OR MY PET FROM INJURY OF ANY KIND, AND AGREE THAT EVEN IF MICHELE'S PET GROOMING AND BOARDING, LLC OR THE RELEASEES CHOOSE TO IMPLEMENT SAFETY PRECAUTIONS, SUCH ACTIONS SHALL NOT ALTER THE FACT THAT I HAVE RELEASED MICHELE'S PET GROOMING AND BOARDING, LLC AND THE RELEASEES FROM ANY DUTY TO PROTECT ME OR MY PET.

In the event of any dispute arising from this Agreement or from any pet's attendance, I agree to immediately pay, on demand, all reasonable attorney's fees and other costs incurred by Michele's Pet Grooming and Boarding, LLC.

14. I understand that this Agreement contains the entire agreement between Michele's Pet Grooming and Boarding, LLC and 1.1 agree that the terms and conditions of this entire agreement shall be binding upon me and my successors, heirs, legal representatives and assigns.

15. I HEREBY WAIVE ANY AND ALL RIGHTS TO TRIAL BY JURY AS TO ANY MATTER ARISING UNDER THIS AGREEMENT.

16. I HAVE READ AND FULLY UNDERSTAND THE TERMS OF THIS AGREEMENT AND UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE AND INTEND IT TO BE COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT PERMITTED BY LAW. I AGREE THAT IT IS INTENDED THAT ALL TERMS OF THIS AGREEMENT CONTROL DESPITE ANY PARTICULAR STATUTE OR LAW THAT WOULD OTHERWISE PROTECT ME OR MY PETS.
